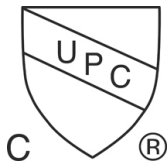

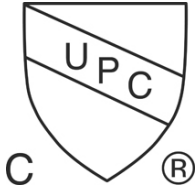

### Identification:

Each ball valve shall be permanently and legibly marked with the manufacturer's name or trademark, nominal size, maximum rated working pressure at 23 °C (73 °F), and maximum rated working pressure at manufacturer's maximum operating temperature, except for ball valves intended for cold water applications only, which may be marked with "Cold Water Only", "Cold Only", or equivalent text. Integral flexible water connectors shall be marked in accordance with applicable marking requirements of ASME A112.18.6/CSA B125.6. Ball valves with push-fit fittings shall be marked in accordance with the applicable marking requirements of ASSE 1061.

Markings shall be visible after installation. Permanent markings may be applied to the ball valve body or handle. Alternatively, hand-tags shall be an acceptable means of applying permanent markings. Product shall also bear the cUPC® certification mark.

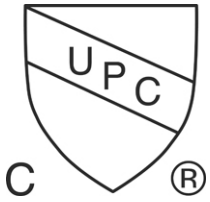
### Characteristics:

Ball valves in sizes NPS-1/8 to NPS-4, with minimum rated working pressures of 860 kPa (125 psi) at 23 °C (73 °F), intended for use in water supply and distribution systems. To be installed with other listed fittings, in accordance with the manufacturer's instructions, and the requirements of the latest edition of the Uniform Plumbing Code and the National Plumbing Code of Canada.

Products listed on this certificate have been tested by an IAPMO R&T recognized laboratory. This recognition has been granted based upon the laboratory's compliance to the applicable requirements of ISO/IEC 17025.
